THE COMMUNITY DIAPER BANK OF UINTA COUNTY AND THE COMMUNITY DIAPER BANK OF BRIDGER VALLEY ARE MADE POSSIBLE WITH THE HELP OF VOLUNTEERS WHO DISTRIBUTE DIAPERS AND PARTNERSHIPS WITH UINTA BOCES 1 AND LYMAN TOWN HALL.
